MINISTRY OF COMMERCE AND INDUSTRY- THE BOILER ATTENDANTS' (AMENDMENT) RULES, 2026.

The Ministry of Commerce and Industry, Department for Promotion of Industry and Internal Trade vide Gazette Notification G.S.R. 09(E) dated 06.01.2026, notified the Boiler Attendants' (Amendment) Rules, 2026. The amendment modifies Form C of the Boiler Attendants' Rules, 2025 by enhancing the permissible aggregate total heating surface of boilers that may be attended by a boiler attendant from “not exceeding 150 square meters to not exceeding 200 square meters”, subject to the condition that such boilers are located within a radius of thirty meters in the same premises, belong to one owner, and are assisted by the number of firemen as considered necessary by the Chief Inspector of Boilers.

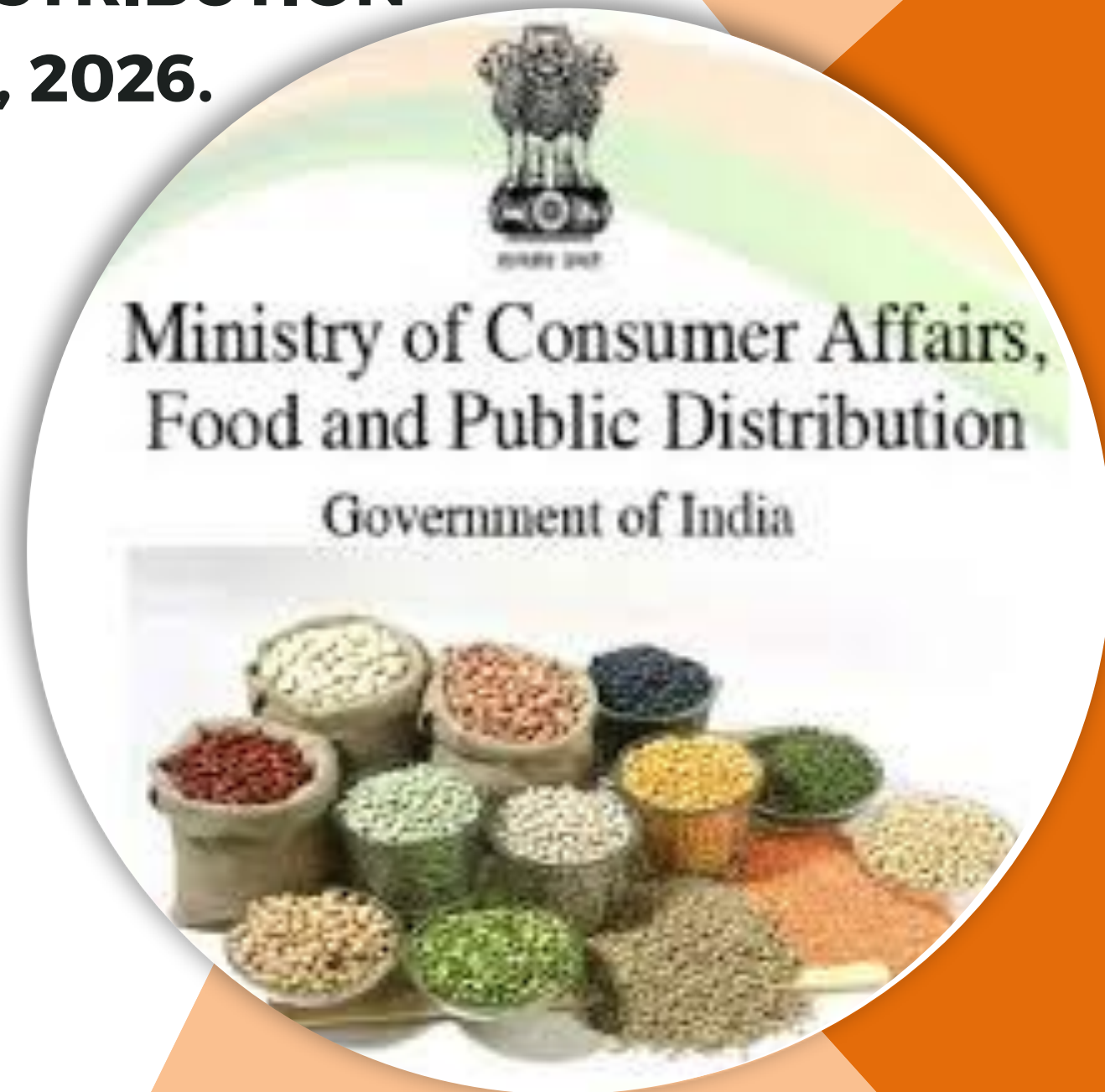

MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION- THE LEGAL METROLOGY (GENERAL) AMENDMENT RULES, 2026.

The Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs) vide Gazette Notification G.S.R. 10(E) dated 07.01.2026, notified the Legal Metrology (General) Amendment Rules, 2026. Through this amendment, in the Legal Metrology (General) Rules, 2011, the existing Part VII-A of the Eighth Schedule has been substituted with a new Part VII-A, prescribing revised metrological and technical requirements for non-invasive non-automated sphygmomanometers, including specifications relating to accuracy, safety, construction, marking, verification and testing procedures.

Ministry of Mines vide Notification G.S.R 22(E) dated 12.01.2026 amends the Minerals (other than Atomic and Hydro Carbons Energy Minerals) Concession Rules, 2016. In Minerals (other than Atomic and Hydro Carbons Energy Minerals) Concession Rules, 2016 the Rule 45(a) (7)- the words (i) “Zirconium and caesium in” shall be substituted with “and Zirconium in”, (ii) “Zirconium sponge and caesium metal” shall be substituted with “Zirconium sponge”. In Rule 45(b)(11) sub rule (12) shall be inserted.

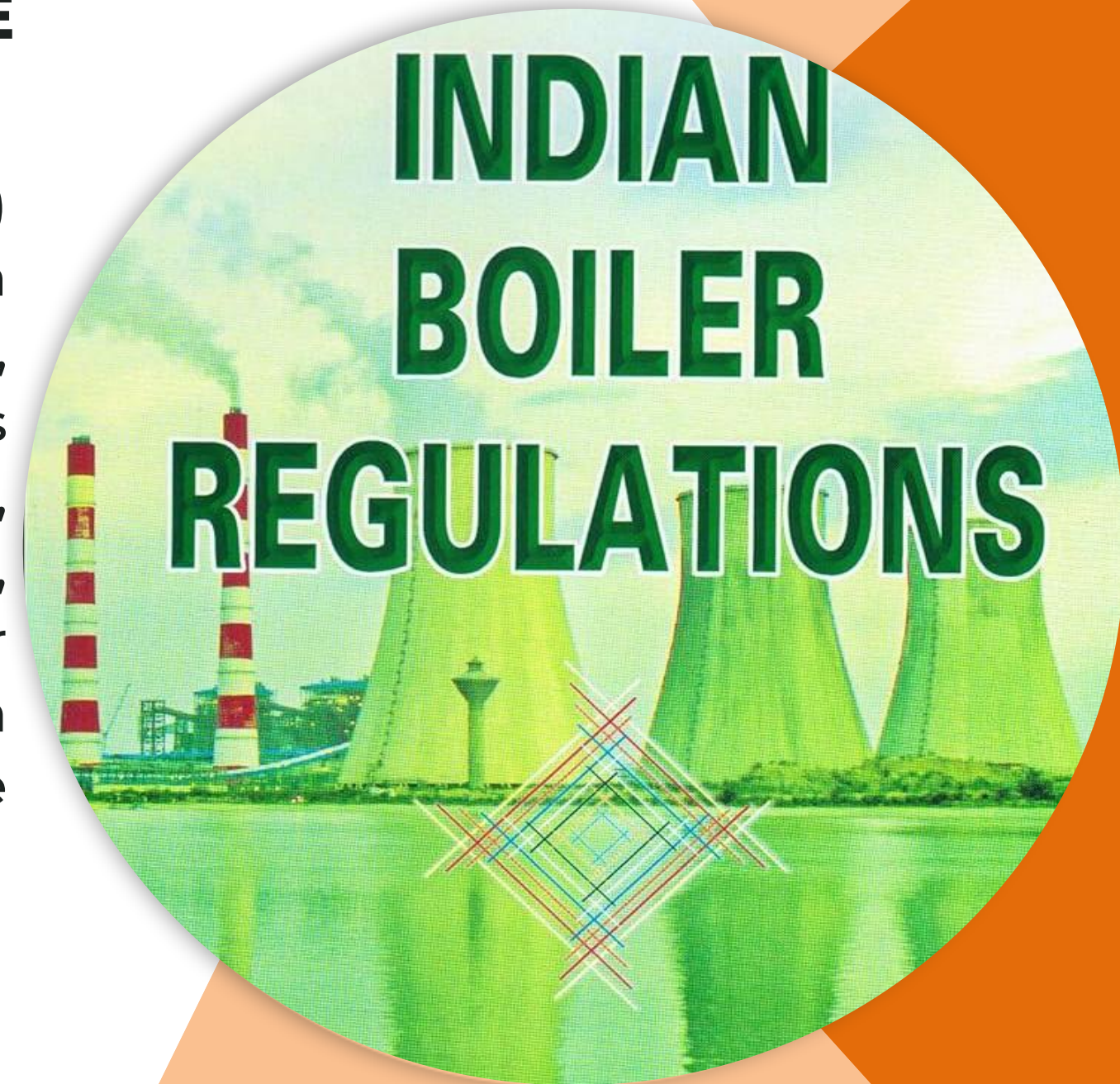

MINISTRY OF COMMERCE AND INDUSTRY- DRAFT OF THE INDIAN BOILER REGULATIONS, 2026

Ministry of Commerce and Industry vide Notification No. G.S.R 31(E) dated 14.01.2026, published draft Indian Boiler Regulations, 2026, in exercise of powers conferred under section 40 of the Boilers Act, 2025, superseding the Indian Boiler Regulations, 1950. The draft regulations prescribe updated provisions relating to applicability, definitions, general and technical requirements, materials, design, manufacture, inspection, certification, and recognition of boiler and boiler component manufacturers, and invite objections or suggestions from stakeholders within thirty days from the date of publication before finalisation.

MINISTRY OF PETROLEUM AND NATURAL GAS- DECLARATION OF RIGHT OF USER FOR LAYING THE PETROLEUM PIPELINE IN ODISHA

The Ministry of Petroleum and Natural Gas vide Notification S.O. 221(E) dated 15.01.2026 issued under section 6 of the Petroleum and Minerals Pipelines (Acquisition of Right of User in Land) Act, 1962, declared the acquisition of the right of user in specified parcels of land in the State of Odisha for laying a petroleum pipeline. The notification pertains to the Hindustan Petroleum Corporation Limited pipeline project from Visakhapatnam (Andhra Pradesh) to Raipur (Chhattisgarh). Upon publication of the declaration, the right of user in the notified land vests in Hindustan Petroleum Corporation Limited, free from all encumbrances, subject to compensation provisions under the Act.

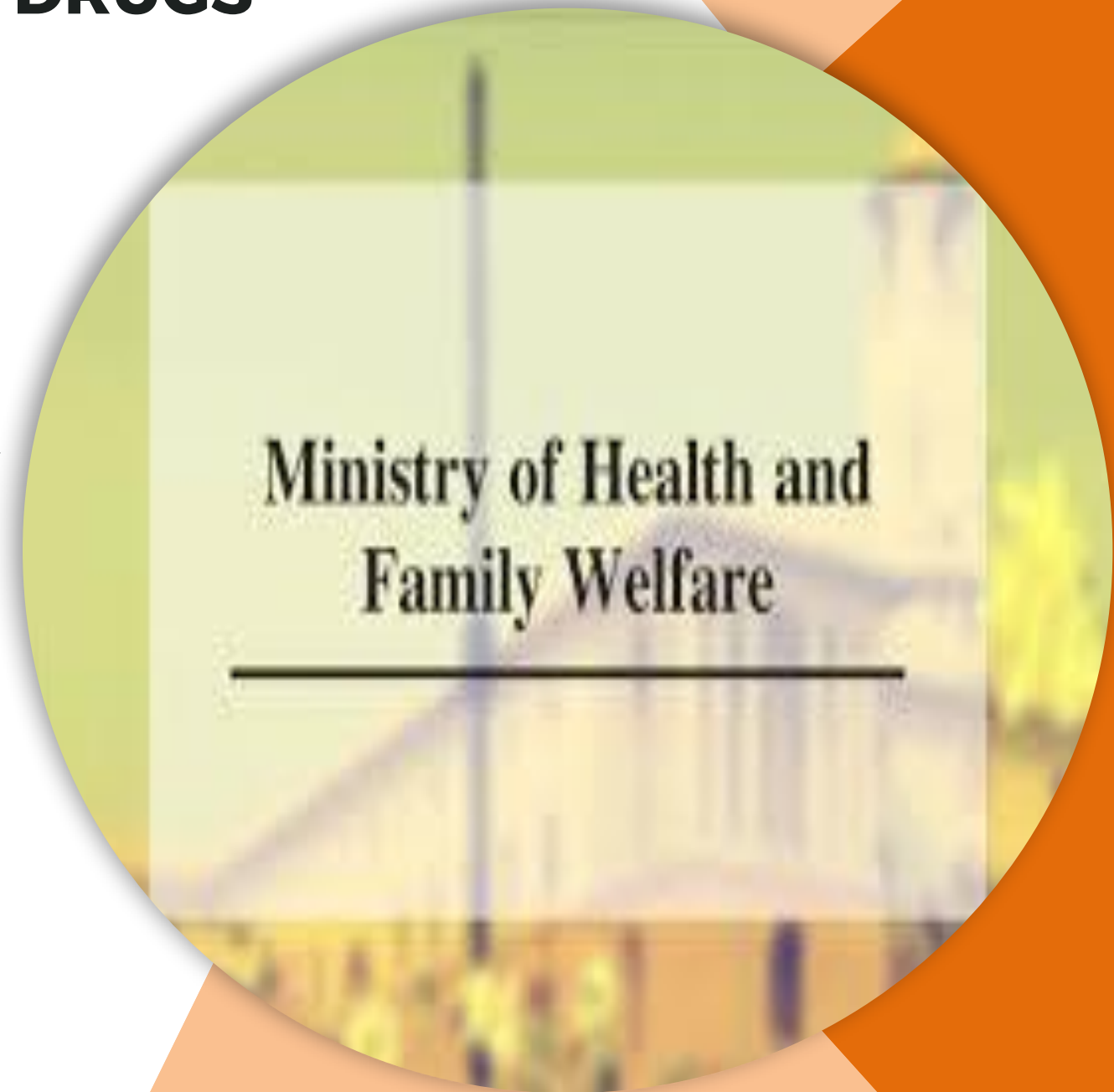

MINISTRY OF HEALTH AND FAMILY WELFARE – THE NEW DRUGS AND CLINICAL TRIALS (AMENDMENT) RULES, 2026

The Ministry of Health and Family Welfare, Department of Health and Family Welfare, vide Gazette Notification G.S.R. 46(E) dated 20.01.2026, notified the New Drugs and Clinical Trials (Amendment) Rules, 2026. Through this amendment, the New Drugs and Clinical Trials Rules, 2019 have been substantially revised to introduce the concept of “permission or prior intimation” for manufacture of new drugs and investigational new drugs for clinical trials, bioavailability and bioequivalence studies, examination, testing and analysis. The amendment reduces regulatory timelines from ninety to forty-five working days in several provisions, streamlines approval processes, prescribes conditions for manufacture based on prior intimation, and provides revised procedures for suspension, cancellation and appeal, along with corresponding changes in relevant application forms under the Eighth Schedule.

Through this amendment, the PNGRB (Technical Standards and Specifications including Safety Standards for Petroleum Refineries and Gas Processing Plants) Regulations, 2023 have been revised to strengthen safety, technical, environmental and energy management requirements, including provisions relating to prevention of fugitive emissions, updated technical references and standards, third-party inspection and maintenance of critical equipment, energy and environmental management systems, fire protection, electrical and control system backups, and other operational safety measures applicable to petroleum refineries and gas processing plants. The Guidelines lay down a regulatory framework for Virtual Power Purchase Agreements (VPPAs) as non-transferable, non-tradable Over-The-Counter contracts between renewable energy generating stations and consumers or designated consumers, to facilitate compliance with Renewable Consumption Obligation (RCO) and Renewable Purchase Obligation (RPO). The notification specifies key features of VPPAs, including minimum contract duration, settlement of price differences between the agreed strike price and market settlement price, transfer and extinguishment of Renewable Energy Certificates, payment and implementation arrangements, and dispute resolution mechanisms, while clarifying that such contracts fall under the regulatory jurisdiction of CERC.

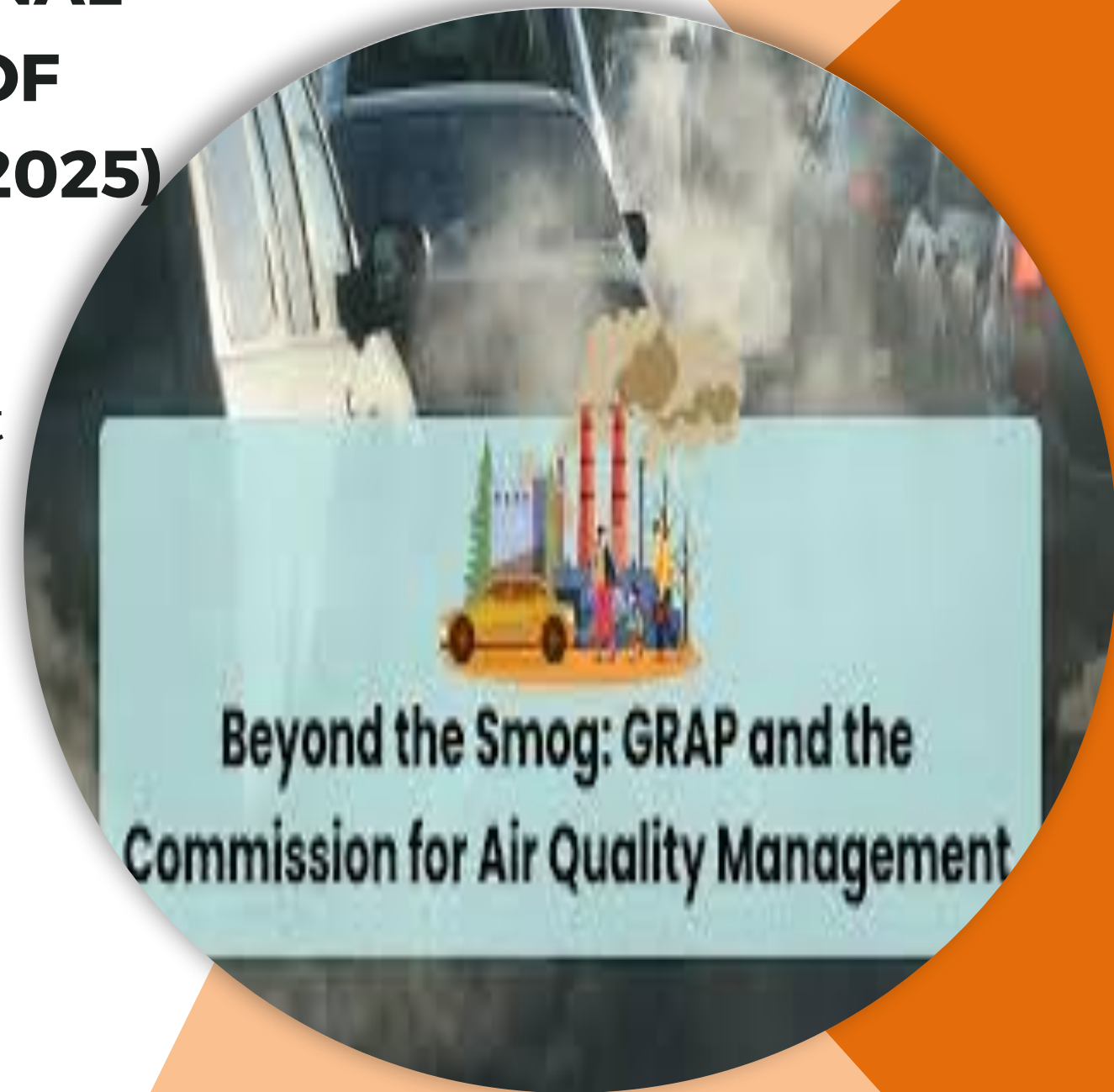
